All applicants to the Community Investment Fund must complete the Door County Community Foundation’s Common Grant Application and this Addendum A. Please note that you may be required to complete additional addendums based on the specific details of your request. The professional staff of the Community Foundation will contact you if more information needed.



Financial support for the Community Investment Fund comes from Destination Door County and the room tax paid by visitors to Door County. Consistent with Wisconsin State

Statutes, to qualify for funding from the Community Investment Fund, your project must be “significantly used by transient tourists and reasonably likely to generate paid overnight stays.”

Given that Wisconsin State Statutes regarding the use of room tax dollars can be complex, we strongly encourage applicants to reach out to the Community Foundation for an informal assessment of their idea prior to the submission of a formal application.
